Round, M.S.Flate & M.S. Angle as mentioned below with following conditions:

- The registration is subject to have valid license for documents related to manufacturing of the subjected items. Please note that it should be renewed Two months in advance before expiry of valid documents submitted by you and further valid documents will have to submit with the tender documents.
- 2. The registration will not apply to any of your branches/offices.
- The registration on the approved list does not guarantee for the award of Contract /Purchase order / Inquiry and the registration shall not be applicable for any proprietary items which is related to OEM.
- If the performance is found unsatisfactory, The Gujarat State Electricity Corporation Limited reserves the right to cancel your name even before the expiry of registration period.

5. In case of change in name or ownership or control of the Company / Firm of the registered vendor, such Company / Firm shall inform in writing along with supporting documents within 30 days of such change.

The Company/Firm shall have to confirm that there is neither change in the infrastructure facilities nor in the products / items and that change is only in the name / ownership / control of the Company / Firm.

In such a case, the company / Firm shall have to submit application and relevant documents as proof that such change is lawful / legitimate along with processing fees of Rs. 5000/-.

In case of shifting of factory premises of the registered vendor, such vendor has to pay re-registration charges towards registration fees and factory inspection shall be carried out as per norms.

- 6. If required, the GSECL shall inspect the factories every two year.
- 7. If you have manufactured any other items, for which your firm is not registered, GSECL reserves the right to reject your tender.
- 8. You have to apply for **re-registration** at least before **two months** from the last date of expiry of registration, failing which the vendor shall not be considered as a registered vendor in the ensuing tenders floated after the due date of re-registrations. If you have applied after the due date of re-registration, your application shall be considered as fresh registration and not as renewal application.
